



**AMATEUR ATHLETIC WAIVER AND RELEASE OF LIABILITY AND  
ASSUMPTION OF RISK AGREEMENT  
(PLEASE READ CAREFULLY BEFORE SIGNING)**

In consideration of being allowed to participate in any way ("Participation"), in the Massachusetts Biotechnology Softball League (the "League"), athletic sports program, and related events and activities, the undersigned acknowledges, appreciates, and agrees that:

1. The risk of injury from the activities involved in this program is significant, including the potential for property damage, bodily injury, partial and/or total disability, paralysis, death, potential social and economic losses and/or damages, and while particular rules, equipment, and personal discipline may reduce this risk, the risk of serious injury does exist; and,
2. I, for myself and on behalf of my heirs, assigns, personal representatives and next of kin HEREBY RELEASE AND HOLD HARMLESS the League, its affiliates, including without limitation League directors, officers, officials, agents, employees, other participants, members, the individuals or individual companies sponsoring each team, the American Softball Association and if applicable, owners and lessors of premises used to conduct the event ("RELEASEES"), WITH RESPECT TO ANY AND ALL INJURY, DISABILITY, DEATH, or loss or damage to person or property, WHETHER ARISING FROM THE NEGLIGENCE OF THE RELEASEES OR OTHERWISE; and,
3. I acknowledge that the condition (or poor condition) of the fields – including the playing surface, field structures (e.g. fences, backstops, benches, etc.), and possible obstacles (e.g. trees, rocks, footpaths, ditches, etc.) – including field conditions related to weather, may directly or indirectly lead to injury. I accept such risks and will not hold the Releasees or others responsible for the condition of the fields and any injury or damage that result from my use of these fields; and,
4. I KNOWINGLY AND **FREELY** ASSUME ALL SUCH RISKS, both known and unknown, **EVEN IF** ARISING FROM THE ACTION, INACTION OR **NEGLIGENCE** OF THE RELEASEES or others, and assume full responsibility for my Participation; and,
5. I willingly agree to comply with the stated and customary terms and conditions for Participation. If however, I observe any unusual or significant hazards during my presence or Participation, I will remove myself from Participation and bring such to the attention of the nearest official immediately; and,
6. I further agree that the waiver and release of liability and assumption of risk agreement provided herein is intended to be as broad and inclusive as permitted by the law of the State in which the League is conducting events or activities and that if any portion of this waiver and release of liability and assumption of risk agreement is held invalid, it is agreed that the balance shall, notwithstanding, continue in full legal force and effect.

**COVID COMPLIANCE WAIVER  
(PLEASE READ CAREFULLY BEFORE SIGNING)**

To assist in keeping volunteers, participants, and residents safe and to minimize the spread of the COVID-19 virus, the League will be requesting that all the Centers for Disease Control and Prevention, Massachusetts State Department of Health, Executive Orders of the Governor of Massachusetts, and local town or city health guidelines for outdoor recreational activities be followed. As a representative of your organization you have agreed to the following:

1. I acknowledge that participation in the league involves inherent risk, which includes risk of exposure to and infection by the novel coronavirus, COVID-19. Although preventative measures have been taken to reduce the spread of COVID-19, risk of exposure and infection cannot be eliminated entirely; and,

2. I willingly agree to comply with all CDC, State, and local guidelines for participation in outdoor recreational activities; and,

3. I assume the risk and all responsibility for the health and safety of myself when participating; and,

4. I have direct knowledge of, have read and understand, the guidelines and protocols which have been issued by the Centers for Disease Control and Prevention, Massachusetts State Department of Health, Executive Orders of the Governor of Massachusetts, and the town(s) or city(-ies) where I will be participating in the league, for decreasing the risk of COVID-19 transmission, including the wearing of masks, handwashing, and social distancing (together, the "Guidelines"). I recognize that the guidelines change frequently and are subject to modifications and revisions. My participation in the league is contingent on providing contact information and cooperating with all contact tracing efforts. Failure to do so may prevent my continued participation in the league.
